OFFICIAL PROMOTIONAL RULES - ARIZONA CHARLIE'S DECATUR

The "Take Home A Hybrid" Giveaway (the "Promotion") begins on August 1, 2026, at 12:01 a.m. and ends on Saturday, August 29, 2026, at 8:00 p.m. Pacific Time ("Promotion Period"). The Promotion takes place at Arizona Charlie's Decatur and Arizona Charlie's Boulder ("Participating Locations"). Eligible True Rewards® members may participate at either/both Participating Locations. Eligible True Rewards members may earn entries through qualifying play into both Weekly Virtual Drawings and the Grand Prize Drawing. Additionally, Hot Seat Drawings will be conducted on designated Weekly Promotional Days.

Each Participating Location will separately award:

- Thirty-two (32) Weekly Prizes; and
- One (1) Grand Prize.

All times referenced in these Official Promotional Rules are local time at Arizona Charlie's (PST), unless otherwise stated. The Promotion is sponsored and administered solely by Golden Entertainment, LLC. The Promotion is presented in partnership with Findlay Toyota ("Prize Partner"). Findlay Toyota's role is limited to serving as the Prize Partner for the Promotion. Findlay Toyota is not the sponsor, administrator, or operator of the Promotion and is not responsible for the collection of entries, selection of winners, administration of promotional activities, or compliance with applicable laws, rules, or regulations related to the Promotion. If any selected entry is determined to be ineligible, the entry will be void and an alternate winner will be selected.

1. ELIGIBILITY

Eligible Participants:

To be eligible for the Promotion, all participants must:

- Be a current active True Rewards® member in good standing;
- Be 21 years of age or older at the time of participation;
- Have a valid photo ID with a matching True Rewards® Club Card.

True Rewards membership is free. Individuals may sign up at either Participating Location.

Ineligible Participants:

- All employees of Golden Entertainment, LLC and its affiliates and their immediate family members.
- All employees of Findlay Toyota and its affiliates and their immediate family members.

2. PRIZE DETAILS

Weekly Virtual Drawing Winners will receive:

- Up to \$500 in Free Slot Play; and
- One (1) Shell Gas Gift Card (\$25 Value)

Weekly Hot Seat Winners will receive:

- \$100 in Free Slot Play; and
- One (1) Shell Gas Gift Card (\$25 Value)

One (1) Grand Prize Winner will be selected at each Participating Location. Each Grand Prize Winner will receive:

- One (1) 2026 Toyota Camry Hybrid (approximate value \$29,200 USD) (the "Vehicle"); or
- \$15,000 USD cash in lieu of the Vehicle.

3. WEEKLY WINNER EVENTS DETAILS

During the Promotion Period, each Participating Location will conduct Weekly Winner Events each Friday and Saturday (each, a "Weekly Winner Event"), for a total of eight (8) Weekly Winner Events per Participating Location.

Each Weekly Winner Event includes two separate award components: (a) two (2) Weekly Virtual Drawings selecting two (2) Weekly Drawing Winners; and (b) two (2) Hot Seat Award Drawings, selecting two (2) Weekly Hot Seat Winners.

a. WEEKLY VIRTUAL DRAWINGS

During the Promotion Period, 16 Weekly Virtual Drawing Winners will receive: up to \$500 in Free Slot Play and one (1) Shell Gas Gift Card with a value of \$25.

Sponsor will conduct these Weekly Virtual Drawings from eligible electronic entries earned during the applicable Weekly Drawing Earning Period and will randomly select two (2) Weekly Virtual Drawing Winners. Electronic entries earned for a Weekly Virtual Drawing will apply only to the corresponding Weekly Virtual Drawing and will not carry over to future Weekly Virtual Drawings with a different Weekly Drawing Earning Period. b. HOT SEAT AWARD DRAWINGS

During each Weekly Winner Event, Sponsor will randomly select two (2) Hot Seat Winners. Hot Seat Winners are selected based on physical presence and active play at the time of selection and do not require any promotional entries. To be eligible for a Hot Seat Award, a participant must: (1) meet all eligibility requirements in Section 1 of the Official Rules; (2) be physically present at the Participating Location and (3) be actively playing on an eligible gaming device at the time of selection.

4. WEEKLY DRAWING EARNING PERIODS.

Weekly Virtual Drawings will take place on Fridays and Saturdays during the Promotion Period.

b. SATURDAY DRAWING EARNING PERIODS

Weekly Virtual Drawing entries for the Saturday Drawings may be earned at Arizona Charlie's Decatur during the following four (4) weekly periods:

1. Saturday August 1, 2026, at 8:00 p.m. – Saturday August 8, 2026, at 8:00 p.m.
2. Saturday August 8, 2026, at 8:01 p.m. – Saturday August 15, 2026, at 8:00 p.m.
3. Saturday August 15, 2026, at 8:01 p.m. – Saturday August 22, 2026, at 8:00 p.m.
4. Saturday August 22, 2026, at 8:01 p.m. – Saturday August 29, 2026, at 8:00 p.m.

c. DAILY ELECTRONIC ENTRY BLACKOUT

Electronic entries into the Weekly Virtual Drawings are unavailable to be earned every day from 12:00 a.m. through 12:30 a.m. due to scheduled player tracking processing. No electronic entries will be awarded for qualifying activity occurring during this daily processing period.

5. GRAND PRIZE DRAWING DETAILS

During the Promotion Period, each Participating Location will conduct one (1) Grand Prize Drawing. Grand Prize Drawing Entries may be earned from 12:31 a.m. August 1, 2026, until August 29, 2026, at 8:00 p.m. Arizona Charlie's Decatur Grand Prize Drawing will be conducted on August 29, 2026, at 8:30 p.m. on the casino floor at the North-end of the Table Games area.

a. DAILY ELECTRONIC ENTRY BLACKOUT

Electronic entries into the Grand Prize Drawing are unavailable to be earned every day from 12:00 a.m. through 12:30 a.m. due to scheduled player tracking processing. No electronic entries will be awarded for qualifying activity occurring during this daily processing period.

6. HOW TO PARTICIPATE

a. EARNING ELECTRONIC ENTRIES

Participants will receive one (1) electronic entry into both the applicable Weekly Drawing and one (1) electronic entry into the Grand Prize Drawing for every 250 same-day base points earned on any eligible gaming machine. Base points may be earned through qualifying play on reel slot machines; video reel machines; video poker machines; electronic keno machines; and rated live table games, including live keno and live bingo.

b. ELECTRONIC ENTRY ALLOCATION

Participants earn entries into both the Weekly Virtual Drawings and the Grand Prize Drawing through the same entry method; the only difference is the applicable earning period.

All eligible entries earned at any time during the Promotion Period will automatically be included in the Grand Prize Drawing Drum, regardless of the Weekly Virtual Drawing Earning Period. Entries earned during each Weekly Virtual Drawing Earning Period will only be eligible for the corresponding Weekly Virtual Drawing and such entries will not carry over from one Weekly Virtual Drawing to another.

c. BASE POINT EXCLUSIONS

The following do not count toward earning electronic entries: (1) food and beverage purchases; (2) bonus points; (3) multiplier points; and (4) any points not classified as base points.

d. ADDITIONAL REQUIREMENTS

This is a points free premium promotion; thus, points are not deducted from a Participant's True Rewards account. True Rewards cards must be properly inserted and accepted by the gaming device to earn entries. Table Game players are responsible for ensuring play is properly rated. e. WEEKLY DRAWINGS

Weekly Virtual Drawings will be conducted at 6:15 p.m. and 8:15 p.m. each Friday and Saturday during the Promotion Period. Participants are responsible for ensuring their True Rewards card is properly inserted and activated in their account prior to the Virtual Drawing time (between 5:00 p.m.-6:00 p.m. for the 6:15 p.m. Drawing, and between 7:00 p.m.-8:00 p.m. for the 8:15 p.m. Drawing). Participants must be present to win. One (1) Weekly Virtual Drawing Winner will be selected during each scheduled drawing at each Participating Location, with a total of two (2) Weekly Virtual Drawing Winners selected on Friday, and two (2) Weekly Virtual Drawing Winners on Saturday.

f. HOT SEAT DRAWINGS

Hot Seat Drawings will be randomly generated and selected through the True Rewards active Player Tracking System. Anyone who is actively playing at the time of the Hot Seat Drawings is eligible to win. Hot Seat Drawings will occur every Friday and Saturday during the Promotion Period between 5:15 p.m.-5:45 p.m. and between 7:15 p.m.-7:45 p.m. Hot Seat Winners must be present to win and must meet all promotional requirements. Hot Seat Winners do not have to earn any specific entries to win.

g. GRAND PRIZE DRAWING

At the conclusion of the Promotion Period, one (1) Grand Prize Winner will be selected at each Participating Location from all eligible Grand Prize entries earned at said Participating Location. The selected Grand Prize Winner may choose either the Vehicle; or \$15,000 USD cash in lieu of the Vehicle. Grand Prize entries must be activated between 7:00 p.m. and 8:00 p.m. on the applicable Grand Prize Drawing date.
